Position Purpose

• The Distribution Manager reports to the Director of Operations and is responsible for warehousing and distribution activities at the AmesburyTruth Sioux Falls facility. This includes responsibility for 50k+ sq. ft of warehousing space, inbound & outbound trucking operations, inventory accuracy, cross-docking operations, expedite shipments, and transportation coordination. As a member of the Operations Leadership Team, the Distribution Manager will have leadership responsible for a team of 15+ team members across multiple shifts, achieving safety objectives, setting Key Performance Indicators, developing personnel, budget/financial management, long-term planning, and implementing continuous improvement projects to improve overall efficiency. As a business partner, this position will work closely with the Customer Service and Manufacturing Managers to achieve overall Operational Excellence.

Essential Duties & Responsibilities

- Responsible for establishing a culture of safety throughout the warehouse, maintaining a safe and secure work environment with a high level of safety awareness among team members.
- Manages compliance of distribution processes to company quality policies and ISO standards.
- Sets Key Performance goals and objectives that are consistent with the Corporate Sales & Service plan.
- Evaluates, develops, and operates within the annual budget; prudently deploys capital; and ensures adherence to personnel budgets.
- Analyzes distribution and logistical problems to develop solutions including hardware and software applications that drive accuracy, efficiency, and customer loyalty. Applies lean principles across distribution operations.
- · Maintains Import/Export systems and processes to ensure compliance with regulatory or legal requirements.
- Ensures warehouse space is optimized for maximum efficiency.
- Develops and implements methods to maintain accurate inventory levels at the facility.
- Conducts annual performance review processes to deliver optimal business results.
- Maintains positive relations with team members. Listens, supports, engages, and encourages suggestions and input to achieve excellent results.

Knowledge / Skills / Abilities

- Ability to conduct critical analysis and assessments to develop action plans that ensure efficient, lean, and effective processes are in-place to produce quality delivery of goods and services.
- Demonstrated strong business acumen, organizational, and analytical skills. Working knowledge of other business functions; i.e., EH&S, Quality, Planning, Finance, Maintenance/Engineering and Human Resources.

- Logistics/supply chain certification desirable.
