### **Position Purpose**

- Participate in planning, developing, and organizing strategic safety plans
- Support and partner with local management on safety and health efforts and program management.
- Coordinates local safety activities; such as safety champion training, development, program management and machine guarding.

### **Essential Duties & Responsibilities**

- Develop, implement and monitor safety programs to ensure compliance with federal and state legislation.
- Coordinates annual Emergency Response Team and employee evacuation drills including maintenance of evacuation maps.
- Participates in safety investigations, document root cause and recommends corrective action where occupational hazards exist.
- Participates in the development and distribution of monthly safety toolbox training.
- Provides training, conducts workplace incident investigations and internal audits.
- Participates as an active member of the safety panel reviews and local safety committees.
- Develops and analyzes safety metrics for actions and activities to reduce workplace hazards.
- Participate in return to work efforts in all areas of the facility.
- Provides ongoing updates through formal and informal presentations to key stakeholders.
- Create, implement, and maintain standardized work instructions as related to safety programs.
- Coordinate with local safety champions to provide training and support and ongoing continuous improvement.
- Assists in the design, evaluation and implementation of machine guarding.
- Participates in continuous improvement events.

- Ability to maintain and inspect safety related equipment according to ANSI and OSHA standards.
- A thorough knowledge of government, safety and environmental regulations.
